▲ Regular Board Meetings:

1. DRWD will occur on the second Tuesday of the month; except in May due to Spring 2027 ACWA
2. WDWA GSA, WWA, BWSD and WWQC will be on the Wednesday following the second Tuesday of the month; except in May due to Spring 2027 ACWA
3. BMWD and LHWD, will be on the Thursday following the second Tuesday of the month; except in May due to Spring 2027 ACWA

Additional notes:

▲ **WWA Trustee** meeting is for notes only – it is not a public meeting

WWA board meetings will address common items to districts, including supply/demand analyses, allocation updates, etc.

- All non-WWA board members from BWSD, BMWD, LHWD, and DRWD are encouraged to attend

Updates in March, May, August, and November will be focused on standard activities including quarterly financial reviews:

- March’s board meetings will include a review of (prior) **year-end financials**
- May’s board meetings will include **Q1** financials
- August’s board meetings will include **Q2** financials, prior-year **audits**, and **preliminary budget outlook** for the next year
- November’s board meetings will include **Q3** financials and **budgets** for the next year

Financials will be sent **monthly** to all board members of each entity for review, but approval will only be sought at the regularly scheduled board meetings

▲ **Note:** every **odd** year (2025, 2027, etc.) there will usually need to be a board meeting for BWSD after January 1st and BMWD, LHWD, and DRWD in September (after mid-August) to “make appointments in lieu of an election” as applicable
