Brad Kroeker arrived at this point in the meeting.

The Manager reported on the following items regarding the DCP: 1) DWR approved the California Water Fix: construction of two 35 mile tunnels and a facility to move water under the Delta to SWP and Central Valley (CVP) pumping facilities on July 21, 2017; 2) Governor Newson announced he did not support two tunnels on February 12, 2019, but would support the project if amended to one tunnel: Delta Conveyance Project (DCP); 3) in October 2020, KCWA reported that the project will take four years of funding to plan the project and construction will take 10-15 years; 4) Belridge Water Storage District, Lost Hills Water District, and the District entered into an agreement with KCWA and other Member Units to fund the first two years of the DCP planning process and to participate at 50 percent, 50 percent, and 35 percent, respectively; 5) KCWA is requesting Member Units decide to participate in the remaining two years of funding the DCP planning costs by April 28, 2022; 6) the planning of the DCP project is on time and on budget; 7) KCWA is asking for a decision by April 28, 2022 so that DWR can incorporate DCP charges into its July Statement of Charges and avoid rebilling; and 8) Risks: planning cost not recovered if DCP construction does not proceed, publicly available updates will not be released until after EIR/CEQA is released in the summer of 2022, and updated construction cost estimates will not be available until 2023.

## Presentation by SWP Principal Operating Officer Tony Meyers regarding DCP Status:

Tony Meyers presented the following information regarding the DCP: 1) purpose: Modernize the SWP infrastructure in the Delta to restore and protect the reliability of SWP water deliveries; 2) objectives: address rising sea levels and climate change, minimize water supply disruption due to seismic risk, protect water supply reliability, and provide operational flexibility to improve aquatic

conditions; 3) engineering summary; 4) engineering input for impact analysis; 5) Bethany Reservoir Alignment; 6) stakeholder engagement committee update; 7) public outreach and community engagement plan for 2022; 8) estimated project cost is \$15.9 billion: includes construction, management, oversight, mitigation, planning, soft costs, and contingencies. Costs will be refined if or when an alternative is selected; 9) planning schedule; and 10) planning is on schedule and on budget.

Tony Meyers informed the Board that it is anticipated that bonds will be available to finance the DCP. Once bonds are available, planning costs will be reimbursed to those who have funded the planning process for the California Water Fix and the DCP.

Tony Meyers left at this point in the meeting.

<u>Discussion Regarding Further DCP Participation for 2023 and 2024:</u> Following discussion, the Board recommended moving forward.

Amendment No. 1 DCP to KCWA Planning Member Unit Funding Agreement (BWSD, BMWD, and LHWD): Following discussion, on motion of Alan Scroggs, seconded by Leon Elwell, and motion carried, the Board authorized execution of Amendment No. 1 DCP to KCWA Planning Member Unit Funding Agreement subject to confirmation by Legal Counsel of reimbursement through the issuance of bonds to those who have funded the planning and design of the DCP on the following roll call vote:

Review of 2021 CVC Losses: The Manager reported that Staff received inquiries from Landowners regarding higher-than-average banking recovery losses. The Manager presented a graph of 2021 CVC flows and losses by month. Historically, losses range between 3 to 3.5 percent on average. The graph showed higher than average losses, up to 5 percent, in CVC Pool 1 between March and June 2021. Staff continues to work with KCWA regarding banking recovery losses. Leon Elwell left at this point in the meeting.

Ad Hoc Committee to Review and Make Recommendations Regarding Accounting for WWA and Member District Assets, and Payment of SWP Charges: The Manager recommended appointment of an ad hoc committee to review and make recommendation regarding accounting for WWA and member district assets, and payment of SWP charges through the WWA. Following discussion, the WWA Chairman appointed himself and Mike Nordstrom to the ad hoc committee.
